Investment Objective

To provide long-term total return consistent with the high yield market.

Investment Strategy

A bottom-up approach is used to uncover securities with stable and/or improving fundamentals and, just as importantly, prevent purchasing or holding onto securities whose fundamentals are deteriorating (including risk of default).

- No maturity or duration limits; expected duration: 3 to 6 years
- 0% - 20% investment-grade securities
- 80% - 100% high yield securities
- U.S. dollar-denominated securities only

Credit quality ratings: Measured on a scale that generally ranges from AAA (highest) to D (lowest). Not Rated is used to classify securities for which a rating is not available or not applicable. Credit quality ratings for each issue are derived from Moody's Investors Services (Moody's) or Standard & Poor's. When ratings from Moody's are not available, ratings from Standard & Poor's are used. **Standard Deviation:** A measure of the variation of returns compared to the average return of the portfolio. **Sharpe Ratio:** A measure of a portfolio's rate of return above the risk-free rate of return, divided by the portfolio's standard deviation.

Up Capture Ratio: The percent of market return captured by the investment manager's return relative to the benchmark during positive periods. **Down Capture Ratio:** The percent of market return captured by the investment manager's return relative to the benchmark during negative periods. Analysis: Manning & Napier. Based on available data. Alpha and standard deviation have been calculated using quarterly performance. All periods greater than one year are annualized.
